A reque or may no control location, uch a cloting area, blocking pede rian and ehioular raffic, enforcing quite one, e.c. Film cre are e pected obeu nob tuite, repectuland follo all Uniter i policie and and and ard.

Reque mu be gi en o he Uni er i y, in ri ing, a lea 72 hour prior o he propo ed da e and ime of en ering he UT campu for filming. E cep ion may be gran ed by UT admini ra ion.
